## 2022 At Home Stores LLC "Ty Pennington Consultation" Sweepstakes

## Official Rules

BY SUBMITTING AN ENTRY TO THIS SWEEPSTAKES DURING THE SWEEPSTAKES ENTRY PERIOD, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. AMONG OTHER THINGS, THIS CONTRACT INCLUDES INDEMNITIES FROM YOU TO THE SWEEPSTAKES ENTITIES (DEFINED BELOW) AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN A PRIZE. ALL ENTRIES HAVE THE SAME CHANCE OF WINNING.

ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID OUTSIDE THE ELIGIBILITY AREA (DEFINED BELOW), AND WHERE PROHIBITED OR RESTRICTED BY LAW.

At Home Stores LLC ("At Home" or "Sponsor") is offering the "2022 Ty Pennington Consultation Sweepstakes" (the "Sweepstakes"). The Sweepstakes is subject to these official rules (the "Official Rules"), and by entering, entrant ("Entrant") agrees to be bound by them and the decisions of Sponsor, which are final and binding in all respects. The Sweepstakes will be administered by Robust Promotions LLC (the "Administrator").

**SWEEPSTAKES PERIOD**: The Sweepstakes starts at 9:00:01 AM Central Time ("CT") on February 23, 2022 and ends at 10:00 PM CT on April 5, 2022 (the "Sweepstakes Entry Period"). Administrator's computer is the official timekeeping device for entry in the Sweepstakes.

**ELIGIBILITY:** The Sweepstakes is open to persons who, at the time of entry and through awarding of any prize, are: legal residents of, and physically located within, one of the fifty (50) United States or the District of Columbia (the "Eligibility Area"); who are at least eighteen (18) years of age, or the age of majority in their state of residence, whichever is older. VOID OUSTIDE THE ELIGIBILITY AREA OR WHERE PROHIBITED OR RESTRICTED BY LAW. Employees, contractors, directors, officers, Sponsor, its affiliates. subsidiaries. Administrator. advertising/promotion agencies and the immediate families (spouse, parent, child, sibling, grandparent, and spouse and "step" of each) and members of the same household of each such person (whether or not related) are not eligible to enter or win. All entries submitted in compliance with these Official Rules and not disqualified or void are considered "Eligible Entries." All entries are the property of Sponsor.

If you are currently a Member, or once you successfully complete the registration and become a member (a "Member"), there are two (2) methods for entering the Sweepstakes by making a purchase:

- a. <u>In-Store</u>: During the Sweepstakes Entry Period, visit any participating At Home store, make a purchase, and, at checkout, provide the telephone number linked to your Insider Perks account prior to the completion of your transaction (each a "Qualifying In-Store Purchase"). No minimum purchase is required. Qualifying In-Store Purchases must be received between 9:00:01 AM CT on February 23, 2022 and 10:00 PM CT on April 5, 2022. Qualifying In-Store Purchases are subject to all notices posted including, but not limited to, Sponsor's Privacy Policy. If Sponsor issues a refund to Entrant or if Entrant initiates a payment dispute or charge-back for any Qualifying In-Store Purchase, all entries associated with the Qualifying In-Store Purchase will be revoked. No entries will be given if the Insider Perks account is not linked at the time of purchase.
- b. Online Store: During the Sweepstakes Entry Period, visit At Home's online store at www.athome.com, make a purchase, and, at checkout, log in using your Insider Perks log in (each a "Qualifying Online Store Purchase"). No minimum purchase is required. Qualifying Online Store Purchases must be received between 9:00:01 AM CT on February 23, 2022 and 10:00 PM CT on April 5, 2022. Qualifying Online Store Purchases are subject to all notices posted on www.athome.com including, but not limited to, Sponsor's Privacy Policy. If Sponsor issues a refund to Entrant or if Entrant initiates a payment dispute or charge-back for any Qualifying Online Store Purchase, all entries associated with the Qualifying Online Store Purchase will be revoked. No entries will be given if the Insider Perks account is not linked at the time of purchase. NOTE: Message and data rates may apply if using a mobile device to visit or make a purchase online.

Insider Perks Members: For each Qualifying In-Store Purchase or Qualifying Online Store Purchase made during the Sweepstakes Entry Period, the Insider Perks Member associated with the account entered (at checkout for a Qualifying In-Store Purchase or at log in for a Qualifying Online Store Purchase) will receive one (1) entry into the Sweepstakes.

<u>Insider Perks VIP Members:</u> For each Qualifying In-Store Purchase or Qualifying Online Store Purchase during the Sweepstakes Entry Period, the

Insider Perks VIP Member associated with the account entered (at checkout for a Qualifying In-Store Purchase or at log in for a Qualifying Online Store Purchase) will receive five (5) entries into the Sweepstakes.

Except as provided in these Official Rules, there is no limit to the number of Qualifying In-Store Purchases or Qualifying Online Store Purchases an Insider Perks Member or Insider Perks VIP Member may make during the Sweepstakes Entry Period. Insider Perks Member information used to gain entry into the Sweepstakes by anyone other than the registered Insider Perks Member shall be void.

All valid entries received through the Qualifying In-Store Purchase or Qualifying Online Store Purchase methods will be included in the drawing for the Grand Prize. All valid entries received through the Qualifying In-Store Purchase or Qualifying Online Store Purchase methods will be included in the drawing for the Store Prize only either for the At Home store location at which the Qualifying In-Store Purchase was made or for the store location designated as 'My Store' on At Home's online store with a Qualifying Online Store Purchase. Entrants using the Qualifying In-Store Purchase or Qualifying Online Store Purchase methods of entry are prohibited from obtaining entry using the Mail-In Entry method.

(2) Without making a purchase or becoming an Insider Perks Member: During the Sweepstakes Entry Period, eligible Entrants may send a hand printed, stamped postcard, postmarked no later than March 29, 2022 and received by April 5, 2022, to: At Home/2022 Ty Pennington Consultation Sweepstakes Entry, c/o Robust Promotions LLC, 164 S. Myrtle Ave., Suite 1, Villa Park, IL 60181 (a "Mail-In Entry"). The Mail-In Entry must be legibly hand printed and include all of the following information on the postcard: first name, last name, street address (no P.O. Boxes accepted), city, state, zip code, birthdate, email address and phone number. Mail-In Entries that do not contain sufficient postage, are missing any information, or are copies or other mechanical reproductions are not permitted for Mail-In Entries and will be disqualified. Sponsor is not responsible for illegible, lost, late, misdirected, postage due, damaged or incomplete entries. Proof of mailing an entry is not proof of receipt. All valid entries received through a Mail-In Entry will be included in the drawing for the Grand Prize. All valid entries received through a Mail-In Entry will also be included in the drawing for the Store Prize only for the one (1) participating At Home store nearest to the address included in the Mail-In Entry, as determined by Administrator in its sole discretion. Entrants are prohibited from combining the Mail-In Entry method with any other method of entry.

Limit one (1) Mail-In Entry per address, per month during each month of the Sweepstakes Entry Period, regardless of the number of individuals residing at the address. For each valid and eligible Mail-In Entry, eligible Entrant will

receive five (5) entries, for a maximum of fifteen (15) entries into the Sweepstakes.

Entries received in excess of the entry limits stated in these Official Rules are void. Entries generated by unauthorized purchased transactions, automated or mechanical means, or means which subvert the entry process will be void. All entries become the property of Sponsor upon receipt and will not be acknowledged or returned.

RANDOM SWEEPSTAKES DRAWINGS/WINNER NOTIFICATION: Winners will be determined via random drawing from all eligible entries received on or about April 7, 2022 by Administrator, Robust Promotions LLC, an independent third-party organization, whose decisions will be final in all matters relating to this Sweepstakes. Odds of winning will be determined by the total number of eligible entries received from all methods of entry combined. Potential winners will be notified by email. If a potential winner does not respond to the notification within five (5) business days, or prize or prize notification is returned as undeliverable, prize will be forfeited. All prizes that are properly claimed will be awarded. Sponsor shall have no liability for a potential winner's failure to receive notices due to the potential winner's spam, junk e-mail or other security settings or for a potential winner's provision of incorrect or otherwise nonfunctioning contact information. If a potential winner cannot be contacted, is ineligible, or fails to claim the prize within the indicated time period, prize will be forfeited. Sponsor is not responsible for technical difficulties, telephone or cell phone service disruptions or other equipment or service issues which might affect the ability of Sponsor or Administrator to notify the potential winner. If the potential winner is an eligible minor in their jurisdiction of residence, prize may be awarded in the name of their parent or legal guardian who will be responsible for fulfilling all requirements imposed on winner set forth herein.

## PRIZES AND APPROXIMATE RETAIL VALUES (ARV):

**Grand Prize:** One (1) Grand Prize Winner will receive: a One Thousand Dollar (\$1,000.00) digital At Home gift card, plus one (1) design consultation with Ty Pennington (conducted virtually).

ARV of the Grand Prize: \$1,500.00.

**Store Prize:** Two Hundred Forty-Two (242) Store Prize Winners (one (1) per participating At Home store location) (each a "Store Prize Winner") will each receive: a Fifty Dollar (\$50) digital At Home gift card.

ARV of each Store Prize: Fifty Dollars (\$50.00). Total ARV of all Store Prizes: Twelve Thousand One Hundred Dollars (\$12,100.00).

Total combined ARV of all prizes: Thirteen Thousand Six Hundred Dollars (\$13,600.00).

Each Store Prize will be fulfilled approximately five (5) business days following Store

Prize Winner verification. Prizes will be sent to the email address provided in winner verification documents. Gift Cards are subject to certain terms and conditions as specified by Sponsor. Each Winner is solely responsible for any federal, state, and local taxes associated with acceptance of their prize.

Grand Prize will be fulfilled in two parts. The At Home digital gift card will be sent approximately five (5) business days following Grand Prize Winner verification. The virtual design consultation portion of the prize will be coordinated with Sponsor. Sponsor will provide Grand Prize Winner with available dates for the virtual design consultation and Grand Prize Winner must select among available dates. In the event Grand Prize Winner is unable to attend on any of the available dates provided, or selects a date but is unable to attend at the designated date/time for any reason, this portion of the prize will be forfeited and Sponsor shall have no further obligations. If Ty Pennington is not available for the virtual design consultation, for reasons including, but not limited to, scheduling conflict, cancellation, postponement, or for any other reason, then Sponsor reserves the right to award only the gift card portion of the Grand Prize only, with no further obligation to the Grand Prize Winner. Grand Prize Winner will be required to supply Sponsor with their social security number for tax purposes. Grand Prize Winner will receive an IRS Form 1099MISC for the ARV of their prize. Grand Prize Winner is solely responsible for any and all federal, state, and local taxes associated with acceptance of their prize.

The releases hereunder are intended to apply to all claims not known or suspected to exist with the intent of waiving the effect of laws requiring the intent to release future unknown claims.

By participating, Entrant agrees that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, Entrant's rights and obligations, or the rights and obligations of Sponsor in connection with the Sweepstakes, shall be governed by and construed in accordance with the laws of State of Texas, without giving effect to any choice of law or conflict of law rules.
